Presentations:

Campus Reading Celebration. Deborah Hoffman explained the Campus Reading Celebration process, and invited everyone to the upcoming appearance by author T.C. Boyle on Tuesday evening, Nov. 14, at 6:30 p.m. in Salon A.

Prop 1D. Marty de los Cobos outlined the benefits of Prop 1D for CSUCI and other entities throughout the State. He encouraged everyone to vote.

Policies:

- 1. Policy on Federal Work Study, 2nd reading. Jane Sweetland reviewed the policy for the Council. Following minor edits, the policy was **recommended** unanimously.
- 2. Policy on Parking and Traffic, 2nd reading. Ray Porras reported that as a result of the September 25 discussion of this policy, bicycle racks will be installed in front of Sage Hall and Manzanita Hall. Discussion ensued regarding safety and theft issues. Ted Lucas suggested that bicycle lockers might be a solution to the theft problem. Ray Porras agreed to look into the locker issue and bring back pictures of various kinds of lockers. Action on the policy was postponed until the next meeting.
- 3. Policy on a Drug-free Workplace, 2nd reading. Eddie Washington reviewed the policy for the Council. Mike Middleton suggested that everyone be required to sign-off on having read and agreed to the policy. Eddie Washington suggested putting copies of the policy in next month's paycheck envelopes. The policy was unanimously **recommended**, with the understanding that Eddie Washington will report back at the next meeting on possible distribution strategies.
